In supersession of WRC communication No. WRC. APW05659/223613/B.ED./313th/2020/208619-208622 dt. 19.03.2020, the case of B.ED. course conducted by **SCHOOL OF TEACHERS EDUCATION, SHRI SATYA SAI UNIVERSITY OF TECHNOLOGY AND MEDICAL SCIENCES BHOPAL-INDORE ROAR, OPP. OIL FED PLANT, PACHAMA, SEHORE, MADHYA PRADESH** was placed before WRC in its 314th meeting held on July 13th to 15th & 22nd, 2020 and the committee decided as under:-

"The is a case of change of affiliating body.

The WRC has permitted change of affiliating body from the date of issue of order. The institution has requested for permission from the date of Gazette Notification.

The WRC has granted permission for change of affiliating body from the Barkatullah University to to Sri Satya Sai University for B.Ed on 07.07.2015 and for B.P.Ed on 08.01.2016.

The Committee considered the request of the institution and after going through all the related documents noted that are two issues involved (1) Change of management of the institution (2) Change of affiliating body of the institution.

On careful perusal of the Agenda note and other related documents, the WRC decided the following :-

- **The WRC office may seek legal opinion from the Law Department of NCTE regarding change of management of the institution.**
- **Regarding change of affiliating body, the WRC decided that the Institution be permitted to change the affiliating body from the date of Gazette Notification by the Govt of M.P."**

Accordingly, the date of affiliation of **SCHOOL OF TEACHERS EDUCATION, SHRI SATYA SAI UNIVERSITY OF TECHNOLOGY AND MEDICAL SCIENCES BHOPAL-INDORE ROAR, OPP. OIL FED PLANT, PACHAMA, SEHORE, MADHYA PRADESH** for its B.ED. course to **SRI SATYA SAI UNIVERSITY OF TECHNOLOGY AND MEDICAL SCIENCES**, is allowed with effect from **19.09.2013** i.e. the date of its gazette notification.
