BLOOD DONATION CAMP

Human blood is an essential element of human life with no substitute. In many major surgeries and trauma emergencies the use of whole blood is now well accepted. Blood transfusion has been responsible for saving millions of lives each year around the world. Yet the quantity and quality of blood pool available for transfusion is still a major concern across the globe, especially in the developing countries.

According to World Health Organization (WHO), the estimated blood requirement for Southeast Asian region is about 16 million units per annum, but it collects just about 9.4 million units, leaving a gap of six million units. India is lagging behind in blood collection in spite of its huge population of over one billion. Blood donors in India, as across the globe, are of three types, voluntary donors, replacement donors and professional donors. Most donations are as a result of replacement donations, which are non-remunerated donations, provided by the relatives of patients. Professional donors are those who donate blood in exchange for money. Replacement and professional donors may be compelled to donate blood, though their health conditions are unsuitable to donate blood. They do not help maintaining a stock of blood for emergency situations. Moreover, they do not provide rare blood groups. These points indicate the need and importance of voluntary blood donations.

SSSUTMS organized voluntary blood donation camp with the help of government medical officials. In this camp, SSSUTMS staff and students donate blood to blood bank who provide blood to needy people. 52 members donate blood in this camp for the needy people and emergency conditions. This camp organise at SSSUTMS campus on dated 15/06/2015.

Sri Satya Sai University of Technology and medical Sciences has established Community Development Cell to integrate various community engagement efforts which are being taken up by various Departments and Centers. The Community development Cell has adopted five villages under Unnat Bharat Abhiyan namely: thuna, Pachama, lasudiya, khamaliya and jamuniya. The University NSS unit has also adopted Thuna village and University Workers' Colony. The mission of Unnat Bharat abhiyan is to enable higher educational institutions to work with the people of rural India in identifying development challenges and evolving appropriate solutions of accelerating sustainable growth. Hence the Sri Satya Sai University of Technology and medical, Madhya Pradesh have adopted 5 (five) different villages by five different departments. In which the Department of Social work have adopted a village named thuna situated at sehore District, Madhya Pradesh. The Community development Cell is taking up various measures for improving livelihood status of the community of the adopted villages. Already a nursery has been set up at Disi village wherein fruit saplings are being grown and distributed among the rural folks. The village school library are also being strengthened and established for minimizing the expenditure on books by the poor parents. Plantation programs are also organized from time to time in the adopted villages where emphasis is given on plantation of fruit bearing trees which will augment their earnings. Awareness programs on health & hygiene, environment conservation, Beti Bachao are also being organized for the benefit of the community. The University students collected cash and kind for the fire victims of adopted village of thuna wherein 38 houses were gutted down. The voluntary initiative provided much relief to the fire victims. A special program under outreach activities on Opium addiction was conducted with the theme; to know how children express their views regarding prevalence of opium in their Society through drawing and writing Essay. Through this program the opium

addicted three districts of Madhya Pradesh namely; lasudiya, Lower Khamalia and Pachama were covered and the harmful effects of the opium addiction were sensitized among the school children. The University Community Development Cell has already submitted proposal for establishment of Centre for Fostering Social responsibility and Community Engagement in Universities to University Grants Commission for augmenting and streamlining the efforts of the community development Cell. Similarly expression of interest for undertaking Evaluation of Sansad Adarsh Gram Yojana (SAGY) under Mission Antyodaya for poverty free Gram panchayats is also being submitted to MHRD for consideration.
