Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Sri Satya Sai University, Sehore).

2.The course will be conducted by senior legal practitioners through simulation and case studies. Evaluation will be conducted in written test (60 marks) practical exercises for( 20 marks) and viva voce for (20 marks) Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Sri Satya Sai University, Sehore).

Interviewing techniques and Pre-trial preparations, Each student will observe two interviewing sessions of clients at the Lawyer's Office/Legal Aid Office and record the proceedings in a diary, which will carry 15 marks as per the given format (30marks). D. the fourth component will be voce examination will be conducted by a panel consisting of internal and external members 10 Marks. (appointed by the Sri Satya Sai University, Sehore).
